

# 特定非営利活動法人セカンドハーベスト・ジャパン

## 賛助会員規程

### 第 1 条 (目的)

本規程は、特定非営利活動法人セカンドハーベスト・ジャパン(以下、「当法人」という。)定款第 6 条第 2 号に規定する賛助会員について必要な事項を定めることを目的とする。

### 第 2 条 (賛助会員)

賛助会員とは、当法人の事業を賛助し、当法人の活動及び運営を支援するため、定款及び本規程の定める手続きに従って賛助会員として入会した法人及びその他団体の当法人の会員をいう。賛助会員は、当法人の総会における議決権を有しないものとする。

### 第 3 条 (入会)

賛助会員として入会しようとする法人その他の団体は、所定の入会申込書を当法人の理事長に提出して入会を申し込むものとする。

### 第 4 条 (年会費)

賛助会員の年会費は、総会決議に基づき次の通りとする。

年会費:1口 100,000 円を1口以上

(2) 年会費は、毎年 1 月 1 日より同年 12 月 31 日の 1 か年(以下「事業年度」という。)の会費をいう。

### 第 5 条 (会費の納入)

賛助会員は、当該事業年度の会費を、毎年1月中に納入するものとする。ただし、事業年度の途中で新たに入会した賛助会員は、入会時期にかかわらず当該事業年度の年会費全額(日割り又は月割り計算はされない)を、入会后速やかに納入するものとする。

### 第 6 条 (会員資格の喪失)

賛助会員は、当法人定款第 9 条に定める事由(①退会、②会員たる法人又は団体の消滅、③継続して 2 年以上の年会費の滞納、又は④除名)により、会員資格を喪失する。なお、理由の如何を問わず、賛助会員が事業年度の途中に会員資格を喪失したとしても、納入済みの年会費は返金されないものとする。

#### 第7条(退会)

賛助会員は、定款第10条の規定に従い、所定の退会届を当法人理事長に提出して退会することができる。なお、賛助会員が、当事業年度の12月31日までに退会届を提出しない場合、当該賛助会員は、翌事業年度も継続して賛助会員となるものとし、翌事業年度の年会費を支払うものとする。

#### 第8条(除名)

定款第11条に定める除名に加え、当法人は、次の各号の一に該当する賛助会員を、当該賛助会員に弁明の機会を与えたうえで、理事会の決議に基づいて除名することができる。

- ①当法人の事業を妨げ又は妨げようとした場合
- ②違法行為又は反倫理的行為に及ぶなど、当該賛助会員が当法人の賛助会員として著しく不適切であると認めた場合

#### 第9条(本規程の変更)

本規程は、理事会の決議によって変更することができる。

#### 附則

本規約は、2024年4月1日より施行する。

## Second Harvest Japan

### 2HJ Supporting Membership Regulations

#### Article 1.

##### (Purpose)

The purpose of these regulations is to define the necessary matters for the supporting membership outlined in Item 2 of Article 6 in the organization statute of 2HJ.

#### Article 2

##### (Supporting Members)

The supporting members refer to corporate members from companies/organizations who have joined as supporting members in accordance with the procedures stipulated in the organization statute of 2HJ and these regulations in order to support the business, activities and operations of 2HJ. The supporting members don't have voting rights at the general meetings of 2HJ.

#### Article 3

##### (Admission)

A company or organization that wishes to join as a supporting member must apply for the membership by submitting the prescribed membership application form to the board chair of 2HJ.

#### Article 4

##### (Annual Fee)

The annual fee for supporting membership based on the resolution of the general meeting of 2HJ is as follows. ①Annual membership fee: 100,000 yen per unit (The system allows for joining with either one unit or multiple units). ②The membership year starts from January 1<sup>st</sup> to December 31<sup>st</sup> of each year.

#### Article 5

##### (Payment of membership fees)

The supporting members shall pay their membership fees for the relevant

membership year in January of each year. Supporting members who newly join in the middle of year will be required to pay the full annual membership fee for that membership year promptly after joining regardless of when they join. Fees calculated both on a daily and monthly basis are not available.

Supporting members shall pay their membership fees for the relevant membership year in January of each year. Those who join in the middle of the year must promptly pay the full annual membership fee for that year upon joining, regardless of the date of entry. Daily or monthly fee calculations are not provided.

#### Article 6

##### (Loss of Membership)

Supporting members will lose their membership status for any of the reasons outlined in Article 9 of the organization statute of 2HJ (① Withdrawal ② Extinction of member company or organization ③ Non-payment of annual membership fees for two years or longer ④ Expulsion). If a supporting member loses their membership status during the year for any reason, the annual membership fee they have paid will not be refunded.

#### Article 7

##### (Withdrawal)

In accordance with Article 10 of the organization statute of 2HJ, supporting members have the right to withdraw from their membership by submitting a prescribed notice of withdrawal to the Board Chair of 2HJ. If a supporting member fails to submit a notice of withdrawal by December 31<sup>st</sup>, they will automatically continue as a supporting member in the following membership year, and they will be required to pay the annual membership fee for that year.

#### Article 8

##### (Expulsion)

In addition to the conditions for expulsion outlined in Article 11 of the organization statute of 2HJ, supporting members may be expelled if they meet any of the following criteria. Providing an opportunity to explain, a member may be expelled based on the resolution of the board of directors of 2HJ. These criteria include:

- ① Obstructing or attempting to obstruct 2HJ activities.

- ② Engaging in behavior deemed extremely inappropriate for a supporting member by 2HJ due to involvement in illegal or unethical conduct.

#### Article 9

(Changes to these regulations)

These regulations may be changed by a resolution reached by the board of directors of 2HJ.

Supplementary provisions:

These regulations are effective as of April 1, 2024
